– Terms and Conditions

By entering this competition, you agree to be bound to these terms and conditions.

1. The Sponsor

The sponsor of this competition is Daisy Education, a company registered in England (company number 09284598) (“the Sponsor”). This competition is not sponsored, endorsed, administered by, or associated with Facebook, Instagram, X, or any other social network.

2. Eligibility

- The competition is open only to schools in the United Kingdom.

- To enter, students must submit a completed Summer Reading Challenge resource activity, including a Bingo Challenge Sheet, Book Recommendation, or Vlog.
- Submissions can be made via the online submission form, or by emailing getinvolved@daisyeducationuk.com if the file is too large. Parents may also submit their children’s completed activities by email.
- If resource sheets are entered by a parent, carer or guardian, they must have confirmation from the child’s school that they would be willing to receive the prize if they win the competition.

4. The Prizes

Three students will be selected via a randomised prize draw to each win:

- a £25 voucher
- a personalised certificate

- Schools can sign up through the Daisy Education website.
