





Terms and Conditions for Reading Plus

Start-up Challenge 2025

By entering this competition, you agree to be bound by these terms and conditions:

1. The Sponsor

The Sponsor of this competition is Daisy Education, a company registered in England - no. 09284598 ('the Sponsor').

2. Eligibility

The competition is open to current licence holders of Reading Plus. The competition is open to schools in the United Kingdom. There is no entry fee and no purchase necessary to enter this competition.

3. The Competition

To enter the competition, schools must register to take part on www.daisyeducationuk.com. The top five schools with the highest reading lessons (on average) on Reading Plus during the competition dates will win Amazon youchers.
